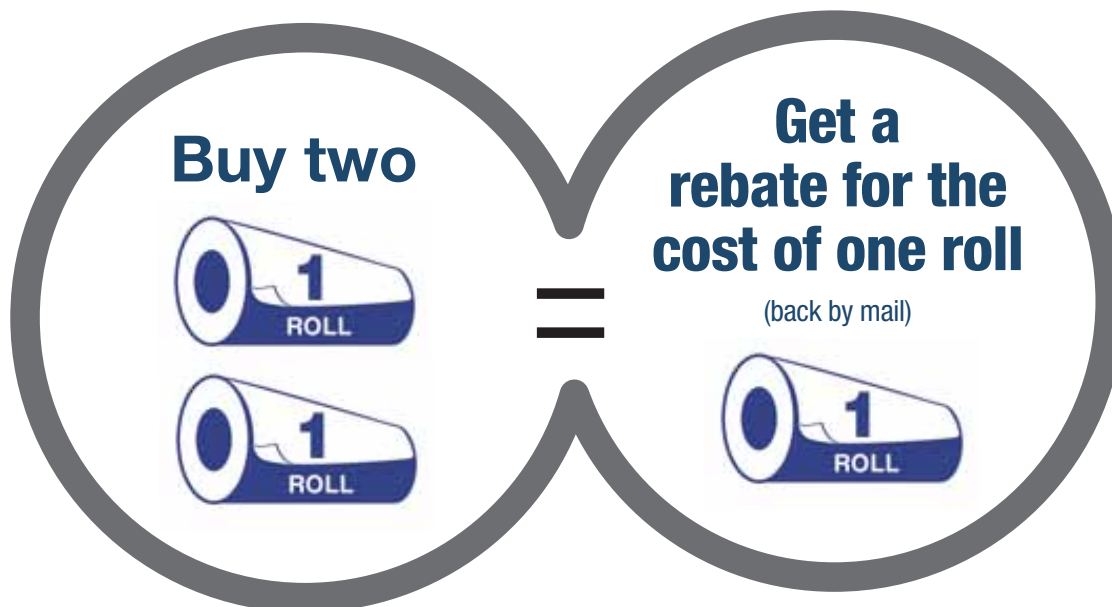


# Mail-in rebate

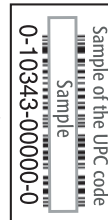
